> Minutes of Clarification Meeting and Site Visit Held on 25 September 2012

## A. CLARIFICATION MEETING

1. The Information (Clarification) Meeting took place on 25 September 2012 at 11:00 a.m. in Municipality of Vladicin Han, Svetosavksa Street № 1 Vladičin Han 17510 Republic of Serbia.

2. The representative of the Municipality of Vladičin Han opened the meeting and welcomed all the participants. In the introductory remarks, the main objectives of the meeting were outlined. The Project Coordinator Serbia, gave a brief overview of the Project and presented the main elements of its scope and were reminded of the importance of being familiarized with the FIDIC general conditions and type of contract and with PRAG rules.

Requirments for the key personnel are stated in the Volume 1\Section 1: Instructions to tenderers Sub-clause 12 position 12.2. (page 11) criteria sub position 3) Technical and professional capacity of candidate, bullet e) Key Personnel. In the case that key personel (e.g. mechanical or electric enginer) is not Contractor's full time employee, Contractor shall submitt together with CV, valid legal form of engagement for that person.
2	What is procedure for payment?	Payments are defined in the Volume 2\ Section 2 Section\ General Conditions for works contracts financed by the European Development Fund (EDF) or European Union Article 50-56 and Section 3\ Special Conditions Article 50.

4. The Clarification meeting was closed at 12:30 hours.

## B. SITE VISIT

1. The Site Visit commenced on 25 September 2012 at 13:00 a.m. in Municipality of Vladicin Han, Location KULA, Republic of Serbia.

2. The site visit started informing the companies about the precise location of the facility and with the brief explanations regarding contract requirements. The tenderers were reminded that the contract to be signed, is a lump sum contract, and informed about the availability of the Tender Dossier and the detailed design of the facility. Also the present representatives of the companies were informed that since the site visit was recommended and not mandatory the companies not present at the site visit can submit the tender as well. It has been mentioned that the tenderers are entitled to ask for clarifications regarding tender dossier at least 21 days before the deadline for submission of the tender expires. No questions were submitted by the participants during the site visit
